Mission Statement: The United Nuclear Industry Alliance (UNI – pronounced “U and I”) is a Supply Chain business alliance, whose mission is to: create innovative business relationships among its Members; create innovative business relationships between its Members and Utilities; facilitate effective local, state, and federal government support that reenergizes the U.S. Supply Chain community; and maximize Members’ ability to compete in the nuclear industry domestically and internationally.

UNI’s creation was announced at the August ANS Utility Working Conference, as a 501(c)(6) non-profit Business League dedicated to the success of the US Supply Chain in the US and globally.

The US Supply Chain is essential to the efficient and effective support for design, licensing, construction, operation & maintenance of nuclear reactors in all phases of their life cycle. With the Light Water Reactors (LWRs) energy portfolio increasing their operating lifetime as well as the future design and deployment of Small Modular Reactors (SMRs), Advanced Reactors (ARs), and innovative fuel designs, the supply chain is now more important than ever.

Growing the Supply Chain globally means being able to (1) participate in projects globally to maximize US content, and (2) working with the US Government (USG) to ensure that products and services can be appropriately exported to foreign nuclear projects.

UNI sponsored a series of meetings with Puerto Rican delegates in late October to discuss the technological advances of Small Modular Reactors (SMRs), the benefits nuclear energy, and how SMRs could be an ideal energy producer for environmentally conscious applications like Puerto Rico.

UNI hosted a meeting of the second Export Strategy Meeting in late September and was attended by over 20 participants from the Supply Chain, Government, and interested parties. A key theme was “How can US Industries and US Government get into new nuclear build countries that have not yet made a reactor technology selection (large and/or small) and help them setup their decision-making processes”.
