

and performance task orders that are issued before the end of this period will not exceed five years beyond the period. The new contract is to replace the existing WVDP Phase 1 Decommissioning-Facility Disposition contract, which is held by **CH2M Hill-BWXT West Valley** and is scheduled to expire at the end of February 2025.

The Department of Energy has awarded indefinite delivery, indefinite quantity (IDIQ) contracts for work to be performed at the **Savannah River Site**, in Aiken, S.C. Each contract includes an ordering period of three years with a ceiling value of \$24 million from December 2023 to December 2026. The DOE granted **S&K Logistics** of Byron, Ga., an IDIQ contract for professional and engineering

support services at the Savannah River Operations Office (SROO) and the National Nuclear Security Administration office. **DNI Emerging Technologies** of Oklahoma City, Okla., was awarded an IDIQ contract for information technology and cybersecurity support services, also at the SROO and NNSA offices.

Savannah River Mission Completion has signed a memorandum of understanding with **Benedict College** to help students prepare for possible careers at the **Savannah River Site**. Benedict, a historically black college in Columbia, S.C., offers a number of fields of study in science, technology, engineering, and mathematics (STEM). The agreement, which remains in effect through

October 2025, focuses on providing work experience in internships and apprenticeships for students in STEM fields that are beneficial to SRMC, as well as opportunities for full-time employment after graduation.

The **Department of Energy** has awarded a small business set-aside contract to **Inomedic Health Applications** for the provision of occupational medical services to federal and contractor employees at the Hanford Site in Washington state. IHA, headquartered in Hampton, Va., is classified as a small, disadvantaged, and women-owned business. The contract was a step for the Hanford facility as it prepared to initiate
